Mr. Leist reported on early planning of the Field house and stated that the Health Department can grant a waiver for a holding tank for the sewage at a minimal cost and stated that local contractor Dennis Martin suggested a 40'x80' building and Mr. Leist stated that a 30'x60' would be sufficient with an estimated \$60 per square foot. The estimated total cost will be \$190,000. Mr. Leist discussed the location of the building. Mr. Bapst reported that the Boosters would be interested in helping with the cost.

Administrative Reports

Elementary Principal Matt Hines reported that the 3rd grade reading results are in and we had 30% passage and 57% met reading retention score on the fall assessment, that we have only seen two other districts results at this time were Huntington and Paint Valley and that we did better than they did at 25% and 27%, that have heard Scioto Valley had 17% passage and Western had 34% passage that and still waiting to see other districts. Mr. Hines stated that last year we had 24% on the fall assessment, and are working on a plan to give students more reading instruction time to utilize Mrs. Pollard and Mrs. Hines as reading teachers the next 3 months before the assessment that the NAEP assessment for 4th grade students will be on 1-31-16 and were selected randomly for the assessment as we have been before that only students selected by NAEP will be taking the assessment that on 1-10/11 there will be Professional Development training with staff in grades 2-5 to develop district pre and post assessments for 3rd 9 weeks content that the assessments will be modeled after the OHIO/AIR Assessments that on 1-12 evening and 1-13 will be attending professional development for the Ohio Leadership for Inclusion (OLI4) that on 1-24 the Beaver Lions Club Spaghetti Dinner will be held from 5-7pm in the cafetorium, and all proceeds will benefit Eastern Local Schools students, that on February 10th Eastern Intermediate Science Fair will be held, it is optional for grades 3rd and 4th, that on 1-31 there will be Science Fair Night held for parents and students in grades 3-5 from 4 to 7 p.m.

"Community Connectors" is starting a new recruitment push to enroll more seventh graders at this time. This initiative is of great benefit to our students and the program is still in need of mentors that The Ouiz Bowl Team has been determined and is preparing for healthy competition that PBIS (Positive Behavior Intervention Support) training will continue with our teams on January 18th, that we will be partnering with The Ohio State University: College of Food, Agricultural, and Environmental Sciences as well as with 4H to implement the "weGrill" program to foster positive relationships among fathers and teens, that I will be attending an upcoming professional development opportunity with Mr. Hines through the OlI4 process on January 12th and 13th, that wanted to recognize the Drama Club and the Vocal Music program for their recent Holiday Performance. It was a great addition and a festive event and wanted to say thank you to Mr. Lykins and Mrs. McKee, and wanted to thank Mrs. Werner and Mr. Stephan for a successful Homecoming and Alumni Band Night. Both events received much praise and recognition from the public.
