

**CHILD AND ADULT CARE FOOD PROGRAM**

**FISCAL YEAR 2018 – MEDIA RELEASE**

The Eastern Local Board of Education announces sponsorship of the USDA funded Child and Adult Care Food Program. This program will effect Eastern Local Schools at 1170 Tile Mill Road, Beaver, Ohio 45613.
